WHAT IS THE PURPOSE OF THE COURT PROCEEDING?	The goal is to appoint a guardian to make medical and financial decisions for an incapacitated person or a minor whose parents are incapacitated or deceased.	The goal is to assist and enable an adult with developmental disabilities to be as independent as possible.												
WHO IS THE PROCEEDING APPROPRIATE FOR?	An incapacitated adult who does not have the cognitive ability to designate, in writing, a health care surrogate or, power of attorney. E.g. a person diagnosed with Alzheimer's, dementia or who is in a coma or vegetative state. Also for a minor whose parents are incapacitated or deceased or, who has received an inheritance or settlement.
